SHORT STAY TOURING AND CAMPING CONDITIONS 2011

- 1 You must report to Reception upon arrival before pitching.
- 2 No refunds will be made under any circumstances. Please ensure you take out adequate travel insurance to cover the cost of your booking.
- 3 No arrivals after 9.00 pm. Electronic Card Access Barriers are in place for your security and we can therefore only accept <u>pre-booked</u> arrivals after 5pm.
- 4 Bank Holidays are subject to a minimum three nights stay.
- 5 The hire of pitches is restricted and it is therefore advisable to BOOK IN ADVANCE.
- 6 Strictly no jet skis, boats or similar craft. Pets, gazebos, open fires, disposable bbq's and fireworks are not permitted.
- We are a family park and do not take single or mixed group bookings. A family is classed by our park as being 2 adults and 2/4 children under 18.
- 8 A pitch is one caravan/motorhome/tent and one vehicle only. Our tariff is priced per caravan/motorhome/tent, not per person.
- 9 The amount of people occupying a caravan/motorhome/tent is restricted to the berth of said unit stipulated by the manufacturer. If it is found that your caravan/motorhome/tent is overcrowded you may be asked to leave.
- Hirers are not permitted to use motorised cars, vans or additional tents/motorhomes as supplementary sleeping accommodation.
- 11 Tents are only accepted up to a maximum of 6 berth.
- 12 Vans/commercial vehicles are not permitted onsite with any caravan/motorhome/tent booking.
- The Booking Fee includes one car per pitch. Additional cars are charged at £5.00 per night, and must be parked on the car park adjacent to our toilet block.
- Pitches must be vacated, not later than <u>12.00 noon</u>: new arrivals are not to arrive before 1.00 pm.
- Touring caravans/motorhomes/tents must be sited within the designated area, by the site warden and allocated at the Park Managers discretion.
- Vehicles are only permitted on the park, if they are insured against third party risks and the driver holds a current driving license.
- 17 We do not allow any motorbikes, motorised scooters or similar vehicles on the Park.

- 18 In the interest of safety, the flying of kites is not allowed on our holiday park.
- 19 To safeguard children and the elderly, a speed limit of 10 M.P.H. is enforced on site. Any person exceeding this speed, or otherwise driving in a heedless fashion will be obliged to take their car offsite.
- 20 The owner of any caravan/motorhome/tent not displaying the correct tag issued by reception will be liable to pay for an additional night's pitch fee.
- 21 Please respect other guests. Noise, music or any other nusiance will not be tolerated after 11.00pm.
- 22 Please use the litter bins provided. Please also ensure that the toilet and shower facilities are left in the condition you would wish to find them.
- 23 Smoking is prohibited in the Toilet and Shower block.
- Our facilities are closed for cleaning at various times during the day. You are advised to check our cleaning schedule upon your arrival, which is on display on the noticeboard.
- 25 Our Out of Hours emergency numbers are available at reception.
- The Company cannot guarantee the occupation of any preferred pitch to any prospective hirer.
- St. David's Park shall incur no liability whatsoever in the event of any part of the site or any of the facilities being unavailable because of unforeseen circumstances or circumstances beyond the Park's control.
- St. David's Park and its employees shall not be liable for any loss, damage to or theft from any caravan, tent or other property, unless the same be caused or contributed to by negligence or default on the part of the Company, its servants or agents.
- 29 Bookings are only confirmed bookings once payment has been received by St. David's Park. Dishonoured cheques are charged at £10.00 each.
- Hiring fees are accepted on the understanding that these Conditions are complied with. St. David's Park reserves the right to terminate permission to occupy any pitch, if in the opinion of the Manager, the person concerned has not complied with the above Conditions or with any Regulations posted on the Park Notice Board by the Management, or in the opinion of the Management, has acted in such manner as to require his/her immediate removal from the Park. The refund of the appropriate proportion of any fees paid in advance shall be sufficient discharge of all obligations to any person who is required to leave the Park for these reasons.
